THE DEU IN CONJUNCTION WITH THE GEORGETOWN COUNTY SHERIFF'S OFFICE AND OTHERS ARREST NINE (9)

(Georgetown, SC) ---In a thirty-six (36) hour period beginning March 5, 2014, the 15th Circuit Drug Enforcement Unit (DEU) Georgetown Office, Georgetown County Sheriff's Deputies, the Georgetown City Police Department and the South Carolina Law Enforcement Division (SLED) executed five (5) search warrants and arrested nine (9) subjects. The operations began in the City of Georgetown followed by the Andrews Community of Georgetown County and ended with two (2) search warrants in the Pawleys Island Community of Georgetown County. The subjects were arrested for charges ranging from; Distribution of Crack, Manufacturing Marijuana, Distribution of Marijuana, Distribution of Marijuana within half mile of school, Possession of crack, Possession of Marijuana, Possession of Drug paraphernalia and a family court bench warrant. During the operations Agents dismantled a marijuana growing operation, seized a combined amount of over 700 grams of marijuana, a small amount of crack, a 9mm handgun, a rifle, and one vehicle. Three subjects are still being sought. Those arrested are:

The arrestees were transported to the Georgetown County Detention Center.
